Opinion

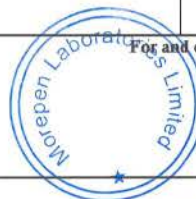

Other Matter

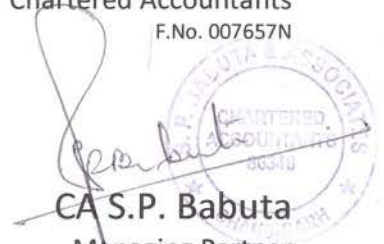
